RELEASE, WAIVER, AND GRANT FORM

SCIENCE RELATED -NON- TRANSPORTATION -MINOR STUDENT

In consideration of North Central College (the College) making available an opportunity for my child to participate in a College related event, I undertake the following on behalf of my child and me:

1. I acknowledge that there are certain risks, to include, but not limited to, serious injury or impairment to other aspects of my or my child's body, general health and well being, which may be both foreseen as well as unforeseen associated with participating in the College related event described below and being transported to or from and do hereby agree to assume such risks; and
2. I accept full responsibility for my and my child's physical and medical condition as well as for such training as may be appropriate for the College related event; and
3. I acknowledge that it is my responsibility to maintain insurance and I do maintain insurance against any damage, loss, or injury that may be sustained by my child or me in consequence of participation in the college related event.
4. I hereby waive and release any and all claims, actions, causes of actions, and demands my child or I may have against North Central College, their agents, employees, representatives, successors, assigns, or any persons operating by or on behalf of the College for, upon or by reason of any damage, loss or injury that may be sustained by me in consequence of participation in the College related event.

This release extends and applies to all unknown, unforeseen, unanticipated, and unsuspected injuries, damages, loss, and liability and the consequences of them, as well as those disclosed and known to exist. The provisions of any state, federal, local, or territorial law or statute providing in substance that releases shall not extend to claims, demands, injuries, or damages that are unknown or unsuspected to exist at the time, to the person executing such release, is hereby expressly waived.

5. Furthermore, I hereby grant full permission to North Central College and their representatives to use my child's or my name and/or picture in any visual or audio reports, recording, or other account of the College related event or its results, for any purpose, without any obligation on the part of any person to compensate me.
6. I hereby agree and understand that the terms hereof shall be binding upon my child, myself, our heirs, assigns, and personal representatives. All matters hereunder shall be resolved in accordance with the laws of the State of Illinois notwithstanding the location of the College related event, the route of travel, or the location of my personal residence.
7. I also agree to follow and comply with, and to insure my child follows and complies with, all the rules of the College related event and with all of the rules and policies in the North Central College Student Handbook and the North Central College Science Department Laboratory Safety Rules. I also understand that my or my child's failure to follow and comply with these rules and policies will result in disciplinary action up to and including expulsion. I also understand that my or my child's failure to follow and comply with these rules and polices will result in me being responsible for any costs that I may incur.

8. This Release, Waiver, Grant shall be binding upon my child, myself, our heirs, successors and assigns, as well as the provider of any insurance carrier maintaining coverage for my child or me. I understand and acknowledge that it my responsibility to inform my insurance carrier of this waiver. This waiver shall be a waiver for North Central College, its directors, officers, agents, employees, and other parties operating by or on behalf of the College or under the direction of the College.
9. In the event North Central College shall be found negligent and accountable in any manner for any damage, loss, or injury sustained by me in consequence of the participation in the college related event, it is understood, agreed, and acknowledged by and between the parties hereto that the College's liability shall be limited to the amount of the deductible on any insurance policy maintained by participant to cover such occurrences or \$500, whichever is less.
